The following procedures must be adhered to:

1. You must provide receipts for all meals, lodging, airfare, tolls, etc.
2. Meal Reimbursement will be for receipts provided but cannot exceed allowances stated in above chart. Alcohol purchases are not reimbursable.
3. All meal receipts must be attached to an 8 1/2" X 11" sheet of paper.
4. The meal receipt should be a detailed cash register receipt containing the name of the business establishment, the date, and time. Smaller restaurants may have written receipts which are also acceptable. **Credit card statements are not acceptable.**
5. Meals must be purchased on the day for which you seek reimbursement and within the starting and ending time of travel.
6. The food purchase must be a single meal item, i.e., no bulk purchases for the total time of travel and no bulk quantity items such as bags of apples, loaves of bread, etc.
7. Meal allowance amount includes tip.
